# Additional descriptions of municipal and non-municipal projects:

## **Community Planning and Environmental Associates**

Don works very closely with another planner, Nan Stolzenburg AICP, on many projects. Nan is located in Schoharie County, and operates under the banner Community Planning and Environmental Associates (CP&EA). The two often partner together and with other planning professionals in order to provide the proper balance of expertise needed for each particular project. Working with Nan, Don has assembled GIS databases, produced resource maps, build-out and viewshed analyses, worked on online and mail surveys, in-person workshops, and all other aspects of the planning process.

# **NYS Department of Environmental Conservation**

## **Environmental Assessment Forms Workbooks**

Partnering with Nan Stolzenburg, Don was co-author of the EAF Online Workbooks. These are a set of online resources that help educate users on how to use the updated short (SEAF) and full (FEAF) environmental assessment forms. In addition to helping write the content of these workbooks, it was Don's responsibility to design and format the workbooks as a series of webpages in order to make them widely accessible and easily updateable.

## **Columbia County Farmland Protection Plan**

Don worked with the Columbia County Agriculture and Farmland Protection Board in developing a county-wide agriculture and farmland protection plan. Specific tasks included identifying and mapping all currently farmed properties, assembling pertinent digital geographic data layers for resource mapping, and leading the board through an in-depth analysis of farmland resources resulting in a prioritized list of farmland preservation locations.

### **Columbia County Soil and Water Conservation District**

Don has provided support and training to staff, including updating and processing of the county-wide tax parcel data for use in their GIS.

# **Columbia Land Conservancy**

# **Protected Lands Map**

Don produced an annual map for Columbia Land Conservancy (CLC) showing all of the publicly owned land and private property with conservation easements located in Columbia County. Using parcel boundary data from the county's Soil and Water Conservation District office and hardcopy maps provided by CLC, digitized the sections of individual properties that are under easement by CLC and other Not-for-Profit organizations.

# **Regional Public Conservation and Recreation Lands Map**

Don produced a map showing all of the publicly accessible properties in an eight county region around Columbia County, New York. Contacted and received data from over 15 different sources, processed the data so it was in a similar format, and modified and refined the information so it was as accurate and complete as possible. This map shows all properties and recreational trails owned by Federal, State, County, and Local governments in the region. It also shows properties owned by individuals and non-profit organizations that are freely open to the public.

# **EAF Workshops**

Don developed and presented two workshops (with Nan Stolzenburg) to provide in-person training on the use of the updated Environmental Assessment Forms adopted by NYS DEC in 2012.

# Village of Kinderhook, Columbia County, NY

Don worked with the village to develop an updated zoning map, incorporating new village boundaries based on extensive deed and survey research. He continues to supply GIS and digital mapping services as needed.

## Town of Canaan, Columbia County, NY

Don provided GIS services and an updated zoning map based on interpretation of the town's 1970's zoning map and recently updated zoning law.

## Town of Hillsdale, Columbia County, NY

Don provided GIS services, digital, and hard copy maps for their comprehensive plan and zoning law update. He has also provided additional mapping services as needed for a farmland inventory, sidewalk inventory, and other smaller projects.

# **Town and Village of New Paltz**

#### Millbrook Preserve

Partnering with Nan Stolzenburg, developed a long range plan for a 230-plus acre undeveloped area straddling the Town and Village of New Paltz. The plan included identification of the areas essential to preserve the natural function and environmental setting of the property. The plan provides both pedestrian and bicycle access into and through the property and identifies ways to help maintain a healthy ecosystem.

# **Brittany Hollow Associates**

### **Hyde Park Zoning**

Don worked with Principal planner Chuck Voss, AICP, on an update to the Town of Hyde Park zoning map. This project included obtaining the most recent parcel data from Dutchess County, and digitizing the hand drawn concept map the zoning committee had been working on. Many revisions where produced as the update was reviewed by the public, the Town Board, and the Planning Board.

## **Tannersville Build-out Analysis**

Don worked with Brittany Hollow Associates and J. Kenneth Fraser Associates, performing a buildout analysis for the Village of Tannersville, Greene County, NY. This project consisted of assembling all available GIS data, analyzing the physical constraints and current developed area within the village's boundaries, and developing a variety of scenarios in an effort to build consensus on the communities preferred future land use build-out.

## Jessie Ravage:

Don worked on three Historic Resource Inventory projects for the Village of St. Johnsville, the Village of Fultonville, and the Town of Lexington. Tasks included developing a historic resource inventory map, and verifying the build-date through information included in the parcel data supplied by the various counties.

## **SHARE-IT, Sharon Springs**

Don produced a GIS database that inventoried all of the historic buildings and sites in a five municipality region including the Towns of Sharon, Springfield, and Cherry Valley, and the Villages of Cherry Valley and Sharon Springs.
